Type: K-12th grade, Swiss, school team sensitive, machine tie breaks (no blitz), 1/2 point bye available for 1 unplayed round except last round.

Sections & Awards: Players may only “play up” 100 points to a higher rated section.

Schedule: Registration from 9:00-9:45 am. All players must check in 15 minutes prior to play in Round 1. Round 1 begins at 10:00 am for Sections 4 & 5; Sections 1, 2, & 3 begin at 10:30 am.

Entry Fee: \$10 if mailed/postmarked by Monday April 17. Late registration is \$10 at the door. Door registrations will receive a 1/2 point bye if not registered 30 minutes prior to their section’s start time.
